- 1) **TO (Name of Supplier):** Insert name of supplier/distributor
- 2) **STREET ADDRESS, CITY and STATE:** Insert address of supplier/distributor
- 3) **DATE:** Date the form is completed
- 4) **No. of Packages:** If product is sold in boxes, indicate the number of boxes needed. If product is sold individually, indicate the units needed.
- 5) **Size of Package:** If sold in boxes, indicate units per box. If sold individually, indicate the packaging size per unit.
- 6) **Name of Item:** Insert name of controlled substance(s) being purchased
- 7) **LAST LINE COMPLETED:** Insert the number of the last line completed in this column.
- 8) **SIGNATURE OF PURCHASER:** Form to be signed by the DEA Registrant

- All narcotics will ship to the address printed on the Form 222 and the Registrant's DEA Certificate.
